

2010 NAHU WILLIAM G. WETZEL EXCELLENCE IN PUBLIC SPEAKING AWARD

Description: The William G. Wetzel Excellence in Public Speaking Award honors members who have demonstrated excellence in public speaking by giving presentations that educate and/or deliver important information to members, industry colleagues, public officials and/or the public. Each appropriately documented presentation is awarded 10 points. The recommended point threshold for this award is 50 points. One award may be given each year.

Criteria:

1. Submit the application form/score sheet along with a detailed but concise narrative describing the purpose and goals of the speaker's presentations.
2. Candidate must have made a minimum of five (5) presentations relating to health care, its allied fields (including but not limited to disability, life insurance, long term care, etc.), or related legislative issues. Of the five required presentations, a minimum of three (3) presentations must be on a different topic. Presentations must be made between April 1, and March 31.
3. Presentations must be made to AHU members, insurance industry organizations, community organizations, or the general public.
4. All presentations require proper documentation as indicated on the Speaker Verification form. No points are awarded without documentation. Presentations organized by the speaker and presented to the general public can be documented with an announcement/invitation and either sign-in sheets or evaluation forms from each attendee. A Speaker Verification form must be included for **each** presentation.
5. An outline of the presentation must be attached to **each** Speaker Verification form.
6. A minimum of 75% or five (5) of the presentations, whichever is greater, require a testimonial letter from the sponsoring organization or completed evaluation forms used at the presentation. The evaluation forms may be of your own design or those used by the sponsoring organization.
