Criteria and Documentation Suggestions

I. NAHU Events

1. Credentialed delegates at National Convention: verified by NAHU Staff
2. Additional registered attendees at National Convention: verified by NAHU Staff
3. State Legislative Chairs attending Capitol Conference: verified by NAHU Staff
4. Additional registered attendees at Capitol Conference: verified by NAHU staff
5. Hosted a one day Regional Meeting: documentation should include invitations sent to the Region, Agenda of the Meeting, and copy of RVP report to BOT showing the meeting took place.
6. Hosted a Regional Meeting (more than one day): documentation should include invitations sent to Region, Agenda of the Meeting, and copy of RVP Report to BOT showing the meeting took place.
7. Registered attendees at Regional meeting: verified by NAHU staff
8. State and Local Membership Chairs at Regional Meeting: verified by NAHU staff. Note, you will receive one point for Membership Chairs and one point for Retention Chairs. If the chapter has the same person for both chairs, one point will be awarded.
9. State and Local Retention Chairs at Regional Meeting: verified by NAHU staff. Note, you will receive one point for Membership chairs and one point for Retention Chairs. If the chapter has the same person for both chairs, one point will be awarded.
10. State and Local Membership Chairs at Annual Convention: verified by NAHU staff. Note, you will receive one point for Membership Chairs and one point for Retention Chairs. If the chapter has the same person for both chairs, one point will be awarded.
11. State and Local Retention Chairs at Annual Convention: verified by NAHU Staff. Note, you will receive one point for Membership Chairs and one point for Retention Chairs. If the chapter has the same person for both chairs, one point will be awarded.
12. Regional Membership and Retention Chairs at Annual Convention: verified by NAHU Staff. Note, you will receive one point for Membership Chairs, and one point for Retention Chairs. If the chapter has the same person for both chairs, one point will be awarded.
13. President-elect attendance at NAHU Leadership Forum at Capitol Conference: verified by NAHU staff

II. Regional Management

1. Holding regularly scheduled State President calls: documentation should include attendance rosters
2. RVP attendance at State Symposiums: documentation could include thank you note from State, Agenda, State Board minutes indicating attendance.
3. RVP attendance at State or Local Strategic Planning Meetings: documentation should include minutes from the Strategic Planning meeting showing attendance, or a thank you letter from the State or Local recognizing attendance
4. Holding regularly scheduled Regional Leadership calls: documentation should include attendance rosters and agendas.
5. Training provided at a Regional Meeting: documentation should include Agenda from the Meeting
 - a. Reviewing with Regional Leadership Blue Chip criteria
 - b. Presenting "Working with the Media" PowerPoint

- c. Presenting "NAHU Website Overview" PowerPoint
- d. Including Membership/Retention training
- e. Including Legislative Leadership and HUPAC training
- f. Including AWARDS/LPRT training
- g. Including Professional Development training
- h. Reviewing options for chapter communication and websites
